I agree in consideration for my participation in the Stryker Stables competition to the following: I agree that "the Federation" and "Competition" as used herein includes the Licensee and Competition Management as well as all of their officials, officers, directors, employees, agents, personnel, volunteers, and NEHC, VHJA, or Federation affiliates. I agree That I choose to participate voluntarily in the Competition with my horse as a rider, driver, handler, vaulter, longer, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I agree that I'm fully aware and acknowledge that horse sports and the Competition involves inherent dangerous risks of accident, loss, and serious bodily injury involving broken bones, head injuries, trauma, pain, suffering of even death (Harm). I agree to hold harmless and release the Federation and the Competition of all claims for money damages or for any other Harm to me, or my horse and for any Harm of any nature caused by me or my horse to others, even if Harm arises or results, directly and indirectly, from the negligence of the Federation or Competition. I agree to expressly assume all risks of Harm to me and my horse, including Harm resulting from the negligence of the Federation or Competition. I agree to indemnify (that is to pay any losses, damages, or costs incurred by) the Federation and Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition. I have read the Federation rules about protective equipment, including GR801, and if applicable, EV114, and I understand that I am allowed to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a Junior exhibitor, I concede to the child's participation and AGREE to all above provisions and AGREE to assume all obligations of this Release on the child's behalf. I represent that I have the requisite training, coaching, and abilities to safely compete in this competition. I agree that if I am injured at this Competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form. Under Vermont Law, an equine activity sponsor is not liable for an injury to, or the death of a participant pursuant to 12.V.S.A Section 1039.
